SEND A SHIRT

M/S GOHEL B M S. is not responsible for any damage / loss to your shirt in shipping it to or from our offices. The shirt will be returned along with your order, and in the same condition that we received it.

Sample shirts will be used purely for measurements, not styling details or shirt construction

Measurements:

Every fabric has a unique weight, feel and fall- hence measurements may appear to be different. Please be prepared for slight variances in fit based on fabrics, You can store the measurements of your custom shirts on your account for future reference. The account will help you save multiple measurement profiles with the option of choosing any while placing your order. When a customer provides us their body measurements, we add a "breathing" margin(0.5") based on the selected fit.

RETURNS / ALTERATIONS

On the first fitting under the fit guarantee promise, if the shirt does not fit quite right, we will complete all reasonable alterations to provide a well fitted shirt. However we reserve the right to refuse alterations if we consider the garment to fit appropriately.

Instances where we will not cover alteration costs include:

• If the alteration is directly related to a change in order requirement from the Customer once the garment has already been produced.

• If the Customer goes against the recommendation or measurement confirmed to us and insists on a particular measurement or style.

• If the Customer's measurements have changed from the date of measurement to the date of fitting.

• If the Customer's measurements change down the track - we do not provide a fit guarantee for the lifetime of the garment.

• We do not provide refund on any shirts sold. Shirts once sold can be replaced/altered only in case of a manufacturing error or if it is covered under our fit guarantee scheme. Since we keep limited inventory, we may not always have the same item that you purchased available with us. Hence we may not be able to replace it for you. In that case, we will provide you with a store credit, which you can adjust the next time you shop with us. We do not permit exchange of a shirt purchased from our site. To return a shirt, the customer must write to us at hello@gohels.com, a prompt response is assured to such mails. We are not liable for any damages caused to the shirt during transit.

• In the unlikely event that you are not satisfied by the order received from us, you can return the product within 7 days from the receipt of the shipment.
